

Garment Guidelines for Military, Law Enforcement, and Firefighters

Standard white, Church-issued temple garments should be worn by endowed members as instructed in the temple. Beehive Clothing no longer produces military garments, but military and certain civil servant organizations that have uniform undergarment requirements have been approved to have organization specified undergarments marked as authorized garments. Organization specified undergarments should be purchased by the patron through approved sources and Beehive Clothing will mark them free of charge.

Only endowed members of the organizations listed below are eligible to have their organization specified colored undergarment clothing items marked by Beehive Clothing. Outer/Second layer or fatigue uniform clothing is not approved for marking.

Beehive Clothing will place marks in organization specified colored undergarment **TOPS AND BOTTOMS** for the following endowed members with a uniform policy:

- Active military personnel
- Customs & Border Patrol officers
- Active military contractors
- Law enforcement bicycle patrol officers

Beehive Clothing will place marks in organization specified colored undergarment **TOPS ONLY** for the following endowed members with a uniform policy:

- Active members of government or civil law enforcement organizations
- Active members of government or local firefighter organizations

Organization specified colored undergarments must meet the following requirements in order to be marked:

- Organization uniform policy dictates that specific colored undergarments must be worn. White undergarments will not be marked. Patrons are directed to wear standard white garments, when white undergarments are permissible.
- Wearing the standard white temple garment could endanger the wearer's life.
- Harsh environments or working conditions are such that wearing an additional undergarment besides the required uniform item would place the wearer at significant risk of harm or injury such as excessive heat.
- Organization insignia, such as name and branch of service, along with clothing manufacturer names and logos are permitted, but no other logos or insignia are permitted.

Printed words or images not in harmony with the

sacred nature of the garment are not permitted (such as weapons, skulls, or crossbones).

- **Organization-specified undergarment tops to be marked must match current garment patterns and styles. Industry-standard tank tops do not meet garment specifications and will not be marked. Tops must be clean, free from stains, and in good condition.**
- **Organization-specified undergarment bottoms will be marked, provided they have an inseam that extends down the leg several inches. Bottoms must be new and never worn.**
- **Undergarments rejected for marking will be returned to the patron.**

HOW TO HAVE UNDERGARMENTS MARKED

1. Purchase organization specified undergarments through military or employment sources.
2. Use one of the following methods to deliver organization specified undergarments to Beehive Clothing:
 - i. Mail in items, along with the completed order form, to Salt Lake Beehive Clothing at the address indicated on the form. Marked undergarments will be shipped back to patron.
 - ii. Bring same-day/walk-in items along with the completed order form during specified hours to the Salt Lake Beehive or American Fork Beehive. Addresses are indicated on the order form. Employment ID may be asked to be provided for employment verification. Endowment verification can be completed one of the following ways:
 - a. Current temple recommend
 - b. Name and birthdate
 - c. Membership #

Undergarment Items will be marked while you wait for approximately 15 to 20 minutes.

- iii. Ship your purchased clothing directly from an online vendor to Salt Lake Beehive Clothing at the address indicated on the form. In addition, email a copy of the completed order form to BeehiveMarking@ChurchofJesusChrist.org. Marked undergarments will be shipped to the patron.

All uniform items submitted for marking that do not meet the requirements as listed will be returned unmarked.
