Terms of the Agreement

1. Rights to Use the Records. You grant IRI full right to create, record, and obtain images, video, audio, and any other content you share or shared during the Interview, including your name, image, likeness, stories, personal history, and any other recordings, documents, or materials you make available in connection with the Interview (collectively, the "Records"). You also authorize IRI to copyright, adapt, edit, summarize, reproduce, perform, display, distribute, transmit, publish, license, sell, broadcast, post or stream over the Internet, create derivative works from, adapt, arrange, translate, recite, communicate to the public, use as a basis for audiovisual works, and otherwise use and allow

others to use any and all parts of the Records and the Interview, forever and throughout the world, in any and all manners, languages, and in any and all forms of media (now known or later developed) that IRI deems suitable. You will have no right in the Interview or in any work that IRI makes or allows others to make with any portion of the Records or the Interview. Moreover, you release IRI from any and all liability (and waive any and all rights of privacy and publicity) relating to use of the Interview and the Records under this Agreement. Nothing in this Agreement stops you from continuing to share the content in the Records with others.

Terms of the Agreement—continued

- **2. Moral Rights.** You waive and will not assert any "moral rights" you may have (including rights of paternity, integrity, attribution, disclosure, withdrawal, or similar rights) now or hereafter recognized in any jurisdiction with respect to the Records.
- **3. Use of Personal Information.** IRI may collect, process, and transfer (into the U.S.A. or another country, as applicable) personal information about you that is shared in the Interview or in the Records, or that is otherwise provided in connection with this Agreement. You are aware of the Church's Global Privacy Notice, available at privacynotice.ChurchofJesusChrist.org, and understand that it governs how IRI processes your personal information.
- **4.** No Obligation to Use. IRI has no obligation to use or maintain any part of the Records, the Interview, or any other information provided by you.
- **5.** No Compensation. You will not receive any compensation arising from or related to the Interview, the Records, or this Agreement.
- **6. Publicity.** Unless you have received IRI's prior written approval, you will not issue or authorize the publication of any news story or publicity relating to this Agreement or to your participation in the Interview.
- **7. Representations.** You represent that you are free to enter into this Agreement and that your performance under this Agreement does not conflict with any other agreement or understanding to which you may be a party.

8. Jurisdiction; Venue. Utah law will govern this Agreement (excluding conflict of law principles), and any dispute will be resolved exclusively in courts in the State of Utah, U.S.A. The prevailing party will be entitled to recover its costs and attorneys' fees. If your performance under this Agreement occurs outside the U.S.A. and a judgment in Utah courts will not be enforceable, any dispute will be resolved by means of binding arbitration under the Rules of Arbitration of the International Chamber of Commerce, with the arbitration to take place in Salt Lake City, Utah, and in the English language. Judgment upon the arbitration award may be entered and enforced in any court of competent jurisdiction, with costs to the prevailing party.

9. Miscellaneous. This Agreement binds and inures to the benefit of the parties, their successors, heirs, assigns, and legal representatives. If a court holds any part of this Agreement to be invalid, except for clauses determined by IRI to be significant or essential, the rest of this Agreement will remain in effect as written. For clauses that IRI determines to be significant or essential, the parties will mutually agree in writing on a replacement provision. If the parties cannot agree on a replacement provision, IRI may terminate this Agreement immediately upon written notice to you. This Agreement is the entire agreement of the parties and may be amended only by a writing signed by each of the parties. In the event of any breach or alleged breach by IRI of any of its obligations to you, you will be limited to your remedies at law for damages and will not be entitled to terminate or rescind this Agreement or to seek equitable or injunctive relief.
