

Garment Guidelines for Military, Law Enforcement, and Firefighters

Standard white, Church-issued temple garments should be worn by endowed members. However, in certain professions, this is not a viable option. Military and certain public service organizations (as listed below) have been approved to wear agency specified uniform clothing items and have them marked by Beehive Clothing as authorized garments free of charge.

Only endowed members of the organizations listed below are eligible to have their agency specified issued clothing items marked by Beehive Clothing.

Beehive Clothing will place marks in agency specified **TOPS AND BOTTOMS** for the following endowed members:

- military personnel
- U.S. Border Patrol officers
- military contractors serving in a combat area and required to wear a military uniform

Beehive Clothing will place marks in agency specified **TOPS ONLY** for endowed members of these organizations:

- special forces
- SWAT team
- FBI or CIA
- firefighters
- police or highway patrol
- undercover police
- police bike patrol officers only may have markings on bottoms
- other equivalent organizations outside the U.S.

Agency specified undergarments must meet the following requirements in order to be marked:

- Uniform policy dictates that no other undergarment may be worn and that the agency specified item is the only undergarment permitted.
- Wearing the standard white temple garment could endanger the wearer's life.
- Harsh environments or working conditions are such that wearing an additional undergarment besides the required uniform item would place the wearer at significant risk of harm or injury such as excessive heat.
- Organization insignia, such as name and branch of service, and clothing manufacturer names and logos are allowed, but no other logos or insignia are permitted. **Printed words or images not in harmony with the sacred nature of the garment are not permitted (such as weapons, skulls, or crossbones).**

- **Tank tops and sleeveless shirts will not be considered for marking. All tops must have sleeves and necklines similar to standard temple garments.**
- **Colored undershorts may be marked (note the designated organizations), provided they are modest and have an inseam that extends down the leg. No minimum length is required.**
- **All agency specified undergarments submitted for marking must be new and never worn. Used items will be returned unmarked.**

Beehive Clothing no longer produces military garments. Agency specified undergarments approved by the organizations listed above should be purchased by the customer through regular military or employment clothing suppliers.

HOW TO HAVE GARMENTS MARKED

After meeting the above requirements:

1. Purchase agency specified undergarments (whether through regular military or through employment clothing suppliers).
2. Use one of the following methods to deliver agency specified undergarments to Beehive Clothing:
 - i. Mail in items, along with the completed form (on reverse side), to the respective address indicated on the form.
 - ii. Hand-carry items, along with the completed form (on reverse side), to the respective address indicated on the form.
 - iii. Ship your purchased item from an online vendor directly to Beehive Clothing. Simply complete the order form on the reverse side of this instruction sheet, scan or photograph it, and email it to BeehiveMarking@ChurchofJesusChrist.org.
3. Verification of endowment and employment is required for in person deliveries and mailed in deliveries
 - i. In Person: Provide current temple recommend or show endowment date on Tools App or provide membership number and birthdate. You will also be required to show your Military/First Responder/Law Enforcement ID badge or provide your badge ID number.
 - ii. By Mail: Include Membership Number, Birthdate and Military/ First Responder/Law Enforcement ID number where requested on form

All uniform items submitted for marking that do not meet the requirements as listed will be returned unmarked.
